being natural persons of the age of twenty-one years or more and citizens of the United States, for the purpose of forming a corporation under the "General Not For Profit Corporation Law" of the State of Missouri, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is SUNSET PARK CONDOMINIUMS ASSOCIATION.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE V

The purpose or purposes for which the corporation is organized are:

This association does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are to provide for the operation, maintenance, preservation and control of SUNSET PARK CONDOMINIUMS, a condominium

located within that certain tract of property described in

Exhibit A andx of a Condominium Declaration dated the 20th
day of Sept. , 1984, recorded in the Office of the Recorder
of Deeds of St. Louis County, Missouri, and to promote the
health, safety, and welfare of the owners within the above-described
property, and for the following purposes:

- a) To have all of the common law and statutory powers of a corporation not for profit which are not in conflict with the terms of these Articles.
- b) To have all the powers and duties set forth in the Uniform Condominium Act except as limited by these Articles and the Declaration of Condominium, hereinafter called the Declaration, and all of the powers and duties reasonably necessary to operate the condominium as set forth in the Declaration and as it may be amended from time to time, including but not limited to the following:

To make and collect assessments against members to defray the costs, expenses and losses of the condominium.

 $$\operatorname{\mathtt{To}}$ use the proceeds of assessments in the exercise of its powers and duties.

To maintain, repair, replace and operate the condominium property.

 $$\operatorname{\mathtt{To}}$$ purchase insurance upon the condominium property and insurance for the protection of the Association and its members.

 $$\operatorname{\mathtt{To}}$ reconstruct improvements after casualty and to further improve the property.

To make and amend reasonable regulations respecting the use of the property in the condominium.

 $$\operatorname{\mathtt{To}}$$ approve or disapprove the transfer, mortgage, and ownership of apartments as may be provided by the Declaration and the By Laws.

To enforce by legal means the provisions of the Uniform Condominium Act, the Declaration, these Articles, the By Laws of the Association and the regulations for the use of the condominium property.

To contract for the management of the condominium and to delegate to such contractor all powers and duties of the Association except such as are specifically required by the Declaration to have approval of the Board of Directors or the membership of the Association.

To contract for the management or operation of portions of the common elements susceptible to separate management or operation, and to lease such portions.

To employ personnel to perform the services required for proper operation of the condominium.

- c) All funds and the titles of all properties acquired by the Association and the proceeds thereof shall be held in trust for the members in accordance with the provisions of the Declaration, these Articles, and the By-Laws.
- d) The powers of the Association shall be subject to and shall be exercised in accordance with the provisions of the Declaration and the By-Laws.
